Tuesday, February 11, 2020

Pursuant to the law, the Atchison County Commission Board met in Regular Session at 1:00 PM on the 1st floor of the courthouse, 423 N 5th St. Atchison, KS. Vice Chairman Eric Noll called the meeting to order with Commissioner Henry W. Pohl and County Counselor Patrick Henderson present for the meeting. Chairman Jack Bower was absent. Deputy County Election Officer, Kalee Vanderweide recorded the minutes.

The Board recited the pledge of allegiance to start the meeting.

***Public Comment:**

There were no Public Comments.

Minutes of the February 4, 2020 meeting were reviewed with no corrections noted. Commissioner Pohl made the motion to approve the minutes. Vice Chairman Noll seconded the motion. Vice Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

***New Business Before the Board:**

Vice Chairman Noll presented a purchase order to J & J Drainage Products for culverts, in the amount of \$35,992.65. Commissioner Pohl made a motion to accept the purchase order to J & J Drainage Products, in the amount of \$35,992.65. Vice Chairman Noll seconded the motion. Vice Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

***County Counselor Updates:**

County Counselor Patrick Henderson mentioned to the Board that the tax sale is ready to be filed this week. As part of that process, the Board must adopt a resolution authorizing the sale.

Counselor Henderson explained that he had sent an email to the townships impacted by the proposed NextEra haul route. NextEra and Counselor Henderson are trying to get an agreement that is acceptable to all involved with this project.

***Introduction and Consideration of Resolutions:**

Counselor Henderson presented a Resolution entitled:
A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ATCHISON COUNTY, KANSAS, CONCERNING JUDICIAL FORECLOSURE AND SALE OF REAL ESTATE TAX LIENS.

Commissioner Pohl moved that the Resolution be adopted. The motion was seconded by Vice Chairman Noll. Vice Chairman Noll called for a vote, all voted aye. The motion passed

2-0. Vice Chairman Noll declared the Resolution duly adopted and the Resolution was then duly numbered Resolution No. 2020-1462 and was signed by the Commissioners and attested by the County Clerk.

Add, abate, escapes for real estate and personal property taxes were presented to be approved.

Bills were presented to be signed.

Commissioner Pohl made the motion to adjourn at 1:15 pm. Vice Chairman Noll seconded the motion. Vice Chairman Noll called for a vote, all voted aye. The motion passed 2-0.
