If you have any symptoms similar to the flu, including fever, cough or shortness of breath, please do not attend until symptoms have subsided and you have been fever-free for 24 hours.

Tuesday, June 15, 2021

Pursuant to the law, the Atchison County Commission Board met in Regular Session at 1:00 PM on the 1st floor of the courthouse, 423 N 5th St. Atchison, KS. A link to the meeting was made available to the public prior to the meeting. In addition, public attendance was available for the Commission meeting via the Zoom platform by visiting the Clerk's Office on the 1st floor of the courthouse, 423 N 5th St., Atchison. Chairman Jack Bower called the meeting to order with Commissioner. Commissioner Eric Noll and Commissioner Casey Quinn were present for the meeting. Deputy County Election Officer Kalee Vanderweide recorded the minutes. County Counselor Patrick Henderson arrived late to the meeting.

The Board recited the pledge of allegiance to start the meeting.

***Public Comment:**

There were no public comments.

***Reading and Approval of Minutes:**

Minutes of the June 8, 2021 meeting were reviewed with no corrections noted. Commissioner Noll made the motion to approve the minutes. Commissioner Quinn seconded the motion. Chairman Bower called for a vote, all voted aye. The motion passed 3-0.

***Commissioner Comments and Committee Reports:**

Commissioner Noll stated that the NEK Multi-County Health Department conducted a shot clinic at the Juneteenth Festival on June 12, 2021, from 1:00 – 3:00 pm. Commissioner Noll was happy to be there.

Commissioner Quinn stated she went out to 286th Road west of 73 with representatives from Vance Brothers to check on the test section of micro seal.

Commissioner Quinn went to the George Johnson Remembrance Walk on Friday, June 11, 2021, at 7:00 pm.

Commissioner Quinn gave a shout out to LaQueta Cluke for organizing an amazing event.

Commissioner Quinn addressed road concerns in her District (3), acknowledged the road plan put together by all three Commissioners and explained that the Road & Bridge Department are working on roads throughout the County in all districts.

***New Business Before the Board:**

Shelly Nelson, Community Corrections Supervisor, presented the Community Corrections Lease Extension to the Board. Commissioner Quinn made a motion to allow

Chairman Bower to sign the lease extension. Commissioner Noll seconded the motion. Chairman Bower called for a vote, all voted aye. The motion passed 3-0.

Wes Lanter, Emergency Management/IT Director presented a purchase order to CDWG, for Trend Micro Worry Free Business Security Services – Maintenance and Trend Micro Worry Free Advanced Licenses, in the amount of \$6,676.00. Commissioner Noll made a motion to approve the purchase order to CDWG, in the amount of \$6,676.00. Commissioner Quinn seconded the motion. Chairman Bower called for a vote, all voted aye. The motion passed 3-0.

Those present will be: the Commissioners and Counselor Henderson. Commissioner Quinn second the motion. Chairman Bower called for a vote, all voted aye. The motion carried 3-0. There was no action taken during the executive session.

Commissioner Noll made the motion to adjourn at 2:00 pm. Commissioner Quinn seconded the motion. Chairman Bower called for a vote, all voted aye. The motion passed 3-0.
