Pursuant to the law, the Atchison County Commission Board met in Regular Session at 1:00 PM at the Atchison County Courthouse, Lower Level, 423 N 5th St., Atchison, KS. A link to the meeting was made available to the public prior to the meeting. In addition, public attendance was available for the Commission meeting at the Atchison County Courthouse, Lower Level, 423 N 5th St., Atchison, KS. Chairman Eric Noll called the meeting to order with Commissioner Casey Quinn and County Counselor Patrick Henderson present for the meeting. Commissioner Jack Bower attended the meeting via the Zoom Platform. Kalee Vanderweide, Deputy County Election Officer recorded the minutes.

The Board recited the pledge of allegiance to start the meeting.

***Public Comment:**

There were no public comments.

***Reading and Approval of Minutes:**

Minutes of the February 1, 2022 meeting were reviewed with no corrections noted. Commissioner Quinn made the motion to approve the minutes as presented. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

***Commissioner Comments and Committee Reports**

Commissioner Quinn met with the Atchison County Extension Board members last Thursday, February 3, 2022.

Commissioner Quinn attended a luncheon on Friday, February 4, 2022, for Steven Johnson, who is running for Kansas State Treasurer.

Commissioner Quinn congratulated Mrs. Finch, on her appointment to City Manager for the City of Atchison.

Chairman Noll stated that the Atchison Child Care Association has their annual Chili & Soup Supper on February 10, 2022.

Chairman Noll stated he had a meeting on Thursday, February 3, 2022, for the North East Kansas Area Agency on Aging (NEKAAA).

***Reports of Elected Officials and Department Heads**

The Yearly EMS Commission Report for 2021 is available on the website. Commissioner Bower stated their numbers are outstanding and the letter from Pat Weishaar, Fire Chief, for the assistance with the fires late last week.

***New Business Before the Board:**

Ron Olinger, CFO at Benedictine College; Scott Crist, UMB Bank; and Kristie Scholz, Controller at Benedictine College; appeared before the Board via Zoom to ask about the potential for Bond Funding to complete St. Gabriel Hall and to complete row housing on 2nd Street. Benedictine College will be asking for \$6.5 million for this bond, not to exceed \$7 million. and hoping to have a hearing and approval on February 22, 2022.

Kalee Vanderweide, Deputy County Election Officer, presented a purchase order to KCAMP, in the amount of \$207,969.00, for the 2022 Annual Contribution. Commissioner Bower made a motion to approve the purchase order to KCAMP, in the amount of \$207,969.00. Commissioner Quinn seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

Kim Glover, Noxious Weed Director, appeared before the Board with the 2022 Management Plan for Noxious Weed. Commissioner Quinn made a motion to approve the 2022 Management Plan for Noxious Weed. Commissioner Bower seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

Wesley Lanter, Emergency Management/IT Director, appeared before the Board with a purchase order to ConvergeOne, for the Meraki Enterprise License & Support, in the amount of \$2,880.36. Commissioner Quinn and Commissioner Bower made a motion to accept the purchase order to ConvergeOne, in the amount of \$2,880.36. Commissioner Bower and Commissioner Quinn seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

Commissioner Quinn made a motion to provide a support letter for the City of Atchison, for their Kansas Department of Transportation (KDOT) cost share Unity Street project. Commissioner Bower seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

Commissioner Bower made a motion to have the Chairman sign a letter of support to Rainbow Communications. Commissioner Quinn seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

Commissioner Quinn made a motion to approve the full appropriation, in the amount of \$29,574.00 to the Regional Crisis Center. Commissioner Bower seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 3-0.

***County Counselor Updates:**

There were no County Counselor updates.

***Public Comment:**

There were no public comments.

Bills were presented to be signed.
